**LIABILITY RELEASE AND ASSUMPTION OF RISK FOR SUPERVISION OF CERTIFIED DIVERS**

---

**This is a release of your rights to sue Aquanauts Grenada True Blue Bay Resort, Spice Island Beach Resort, Blue Horizon Cottages Hotel and their employees, agents and assigns for personal injuries or wrongful death that may occur during dive activities as a result of the inherent risks associated with scuba diving or as a result of negligence of the released parties. Please read carefully and initial each statement:**

----- I acknowledge that I am a certified scuba diver, trained in safe diving practices.

----- I understand that diving with compressed air or oxygen enriched air (nitrox) involves certain inherent risks and accept these risks.

----- I am in good mental and physical fitness for diving, and I am not under the influence of alcohol, nor am I under the influence of any drugs that are contraindicatory to diving. If I am taking medication, I affirm that I have seen a physician and have approval to dive while under the influence of the medication/drugs.

----- I am aware of the danger of breath holding while scuba diving, and I will not hold the released parties and related entities (such as employees, instructors, certified assistants, boat operators, or diver agencies) responsible if I am injured doing so.

----- I am aware that I will be diving with a buddy, and it will be our responsibility to plan our dive allowing for our diving limitations and the prevailing water conditions. I will not hold the released parties responsible for my failure to safely plan my dive.

----- I will inspect all my equipment prior to the activity and will notify the released parties if any of my equipment is not working properly. I will not hold the released parties and above listed individuals responsible for my failure to inspect my equipment prior to diving.

----- I acknowledge that I am physically fit to scuba dive, and I will not hold the released parties responsible if I am injured as a result of heart, lung, ear, or circulatory problems or other illnesses that occur while diving.

----- I understand that even though I follow all the appropriate dive practices, there is still some risk of my sustaining decompression sickness, embolism or other hyperbaric injuries, and I expressly assume the risk of said injuries.

----- I understand that scuba diving is a physically strenuous activity and that I will be exerting myself during this diving excursions and, am injured as a result of a heart attack, panic, hyperventilation, etc., that I expressly assume the risk of said injuries and that I will not hold released parties responsible for the same.

----- I understand that on this open water diving trip, I will be at a remote site and that there will not be immediate medical care or hyperbaric care available to me, and that the nearest hyperbaric treatment center is located on the island of Barbados, I expressly assume the risks of diving in such remote spot.

----- I understand that Aquanauts Grenada Ltd. and its affiliated companies, employees and agents are not liable for any loss or damage to any personal property.
